in countries where homeopathy is not yet officially accepted as a medical system. It is held in cooperation with the European Committee for Homeopathy (ECH) and will be celebrated each year on the occasion of Samuel Hahnemann's birthday.

The International Symposium on Homeopathy, held in Zagreb/Croatia on 24 March 2011, brought together important international and Croatian stakeholders to exchange information about the homeopathic medical doctrine, the current legal framework of medical doctors practicing homeopathy in all continents, and its contribution to European and worldwide healthcare systems. Specific Croatian aspects focused on the national legislation, the registration of homeopathic remedies, and the homeopathic education of Medical Doctors (MDs).

The LMHI was represented by Past-President Dr. Ulrich D. Fischer, General Secretary Dr. Thomas Peinbauer and Treasurer Dr. Yves Faingnaert. In his speech on "Global Homeopathy", LMHI Past-President Dr. Ulrich D. Fischer highlighted the fact that today Homeopathy is practiced by hundred of thousands of medical doctors in all continents and has even gained official status and is integrated into national health care systems in many countries all over the world, such as Brazil, India, Mexico, Pakistan, Sri Lanka and the United Kingdom. Dr. Peinbauer recalled the history of "Homeopathy in Austria", pointing, in particular to the importance of homeopathic education.

ECH President Dr. Ton Nicolai lectured on "Homeopathy – Its Added Value to European Healthcare System." Representatives from the Faculty of Veterinary Medicine as well as from the Faculty of Pharmacy and Biochemistry at Zagreb University presented the Croatian CAM curriculum, including six hours on homeopathy, in the university education process and talked about their experiences in the homeopathic treatment of animal patients and in homeopathic pharmacy. The representative of the Croatian Ministry of Health and Social Care informed

homeopathic medicinal products in

Croatia that was drafted in accordance

with EU directives. CHMS-President Dr.

Jelka Milić indicated in her welcome

address that the CHMS contributed to

the regulation of the Croatian Medical

Chamber's Working Group on Comple-

mentary Medicine that was established

in April 2010 and includes medical

homeopathy, for example by providing the working group with the LMHI/ECH Medical Homeopathic Education Standards translated into Croatian. Dr. Milić also informed the audience about the 3-year-basic medical homeopathic training program beginning for the first time in June 2011 for Croatian medical doctors, veterinarians, dentists and pharmacists. The course is based on the LMHI/ECH standards and will be organized in collaboration with the Austrian Homeopathic Medicine Association ÖGHM.

More than 120 participants used the opportunity to discuss the current status of medical homeopathy in Croatia and the possibilities of its further development and integration into the Croatian healthcare system with officials from Croatian Ministry of Health and Social Care and with the national Medical Chamber Working Group for Complementary Medicine Regulation.

The working languages were Croatian and English, simultaneous interpretation was provided. In addition, Drs. Fischer and Nicolai had a chance to give lectures at the annual family physicians congress (KOHOM congress) hoping that the Croatian Homeopathic Medical Society will be able to recruit General Practitioners for the planned homeopathic training course.



Developing and Securing Homeopathy Worldwide

In political meetings with the Croatian health policy officials, the LMHI and ECH representatives provided political support to strengthen the position of the Croatian homeopathic colleagues. The meetings took place in a positive and encouraging atmosphere. "In these projects, the LMHI really fullfills its purpose of developing and securing homeopathy worldwide as is stipulated in its statutes", LMHI Past-President Fischer stated. Once again, the personal presence of the LMHI and ECH for younger homeopathic associations has proven a powerful and important tool.

Slovenia

Homeopathic Medicines Finally Available

Following the approval of the Slovenian Agency for Medicinal Products and Medical Devices at the end of March 2011, homeopathic medicines have finally become available in Slovenia. Milos Zuzek, Secretary of the Slovenian Homeopathic Society (www.shd.si) reported that the agency has issued five-year permits for 17 homeopathic medicines in a simplified procedure, which means that

Homeopathy...cures a larger percentage of cases than any other method of treatment and is beyond doubt a safer, more economical and complete medical science." Mahatama Gandhi the producer does not have to prove the effectiveness of a homeopathic medicine or present results of clinical studies. Homeopathic medicines will be issued without prescription and are intended for self-treatment. Under the healing act, passed in October 2007, homeopathy can be practiced in Slovenia by medical doctors who have recieved training in homeopathy and obtained a license in accordance with this law. However, a physician practicing homeopathy in fact loses his/her physician's licence issued by the Medical Chamber of Slovenia, preventing him/her from practicing conventional medicine, Zuzek complained. The launch of homeopathic medicines in Slovenia coincided with the World Homeopathy Awareness Week from 10-16 April, 2011.

China

Homeopathic Developments in New LMHI Member China

Homeopathic developments in the new LMHI member country China have accelarated in the recent past and have brought forward a number of national activities. More than 20 new members have joined the new LMHI member organization Chinese Homeopathic Medicine Society, most of them are from the "Guangxi Traditional Chinese Medical University" established in 1956. University President Prof. Tang Nong was elected the first president of the association, while Dr. Steve Xue will continue to serve as the LMHI's National Vice-President (NVP) for China. "LMHI China" has established branch offices in Beijing and in Shanghai. About 60 new members from Beijing and 15 from Shanghai are expected to join the Chinese Homeopathic Society in the coming year. Since Guangxi TCM University is striving to combine teaching, scientific research, medical treatment and drug-production and to build a professional training system in China, Dr. Steve Xue gave three public lectures on homeopathy to the faculty and students. He reported that the university's national key labatory of classical Chinese medicine has been conducting research on the integration of TCM and classical homeopathy, as well as on potentizing Chinese herbs and herbal formulas. The association is planning to organize the first national homeopathy congress in China, and hopes to be able to confirm the date by the fall of this year.

Translation of the Kent Repertory and Boericke Materia Medica into Chinese

Kent's Repertory of the Homeopathic Materia Medica was translated into Chinese and will be made available as both digital program and as hard copy. According to information from NVP Steve Xue, two very prestigious academic publishers in China (Shanghai TCM University Press and Shannxi Normal University Press) have been negotiating with the authors about publishing the hard cover book this summer. Boericke's Materia Medica was also translated into Chinese and is planned to be published in the fall of 2011 by Shanghai TCM University Press.

Chinese Homeopathy Definition: Heliaoyixue

After extensive discussions with linguists, medical sociologists and medical practioners, the Chinese Homeopathic Medicine Society decided to use the term: "heliaoyixue" as the official translation of homeopathic medicine. Defining homeopathy as an independent medical system, the term replaces the traditional "shunshiliaofa", which just meant a medical modality.

LMHI Secretary for Pharmacy visits new LIGA Member China

LMHI Secretary for Pharmacy Dr. Fruzsina Gábor visited Hong Kong and Taiwan at the beginning of the year and gave a series of lectures about the manifold activities of the international homeopathic medical society, especially in the field of research and homeopathic education. Dr. Gábor had the opportunity to meet with the leaders of medical chambers and to talk to medical doctors practicing homeopathy. Together with NVP Steve Xue, Dr. Gábor gave an interview to "Daily China", the largest English-speaking national newspaper in China.

Given the lack of historic background with regard to homeopathy in China, the LMHI is looking forward to its further involvement in the future establishment of an homeopathic education system in China that meets the LMHI Medical Educations Standards. "We will have plenty of work: The most important step should be to complete an education plan and to organize basic homeopathy training courses", Dr. Gábor stated.

Emergency Situation in Japan: How Homeopathy Can Help

According to reports from Dr. Ronko Itamura, the LMHI's NVP for Japan and Senior Director of the Japanese Physicians Society for Homeopathy (JPSH), the whole of Eastern Japan, which includes the Tohoku Region centered on Sendai City, and the Kanto Region, where Tokyo is located and which makes up one-third of Japan's total land area, were ravaged by the triple disasters, first by the massive earthquake, followed by a giant tsunami and a major nuclear crisis. The three hazards have claimed many lives, leaving at least 23,000 people dead or missing and forcing more than 160,000 people to take refuge in makeshift evacuation centers. Most JPSH members in Eastern Japan (463 members as of the present) reside in the Tokyo area, but there are also 32 members providing medical care in Tohoku.

The LMHI has offered help wherever it is needed, such as in the provision of information and advice. The JPSH itself prepared remedies for the treatment of radiation exposure and have issued a prescription manual for the certified JPSH members and for medical specialists. In addition, JPSH supplied homeopathic remedies particularly to member physicians in the vicinity of the nuclear power station in Fukushima Prefecture and responded to requests for supplies from other regions. They have also produced and distributed detailed instructions for homeopathic treatment to alleviate symptoms of anxiety, fear, grief, insomnia, and PTSD observed among the affected people, stemming from their experience of massive loss in the earthquake disaster.

Confirmation 67th LIGA Congress 2012 will take place in Nara,

Japan In view of the nuclear crisis there has been some uncertainty about the venue of the Liga Congress 2012. The LMHI Board of Executives and the Japanese Physicians Society for Homeopathy (JPSH) confirm that the 2012 Congress will take place – as scheduled – in Nara, Japan, from 14 – 17 September 2012. According to JPSH information, the situation of the nuclear problem is improving. The ancient town of Nara is about 600 kilometres (372,67

miles) away from the crippled nuclear power station Fukushima (see map) and Nara is the safest ground in Japan, so that there is no nuclear risk.

"This is a trying time, but we members of JPSH are working hard to prepare for the 67th Congress of LMHI scheduled to be held next year in the ancient capital of Nara in western Japan. We ask for the continued support and cooperation of all LMHI members," Itamura emphasized.

Good news from Switzerland

Re-Integration of Homeopathy in Basic Health Care

In Switzerland, classical homeopathy and four other CAM therapies (anthropology, neural therapy, phyto therapy and TCM) will be reintegrated into the basic health supply (compulsory health insurance) as of 2012. According to a Swiss Health Ministry decision, however, the reintegration will be limited to a period of six years. The final decision will depend on new scientific evidence regarding the "efficacy, cost-effectiveness suitability" by 2017 to prove that these CAM methods are worth as an insurable health cost. Back in 2005, the Swiss government rejected the therapies, arguing they failed to meet the legal requirement of "scientific proof" of the three efficacy criteria. The reversal in policy follows a nationwide vote in 2009 in which two-thirds of the Swiss population backed including the therapies on the constitutional list of paid health services. It also takes into account an opposing recommendation by a federal commission in December to strike them permanently from the list because of a lack of scientific evidence. Complementary and homeopathic medicine proponents welcomed the chance for "fair" assessments. The government's proposal also includes provisions to boost research and training.

Poland

Lawsuit against Former President of Polish Homeopathy Association

As part of a long-standing legal dispute, the Polish Supreme Medical Court examined the case of Jan Baranowski, M.D., former President of the Polish Homeopathic Physicians' and Pharmacists' Association, who had been accused of having used therapeutic methods (i.e. homeopathy) "which are not recognized treatment methods in Poland" and therefore is supposed to violate the Polish Medical Code of Ethics. According to information from Dr. Tomasz Kokoszczynski, the LMHI's NVP for Poland, the legal action is still in progress. Baranowski was found "not guilty" in a decision of the first instance District Medical Court. However, this decision was appealed by the Supreme Medical court that ordered that the case be re-examined.

"The situation of homeopathy in Poland 2011 reflects the ambiguity of today's world and medicine", Kokoszczynski reports. "On the one hand, homeopathy is disapproved by medical authorities who persistently »classify homeopathy as an unscientific method, which promotes the use of worthless products of unproven scientific action." Although not officially recognized in Poland, homeopathy, on the other hand, is not outlawed in any way – only doctors have the right to prescribe higher homeopathic potencies, and the right to treat people. Another fraction of homeopathic opponents in Poland is supported by some church priests, who exaggerate the alleged threats of homeopathy. They assert that "Hahnemann was an occultist, and homeopathy came to him as an revelation". Fact is, however, many patients favor homeopathy in Poland."

The Polish Homeopathic Associations reportedly addressed a letter to the National Board of Health to confirm their will to introduce homeopathy as a medical competence. Independently producers of homeopathic remedies called on the Consumer Protection Agency to review the impact of Supreme Medical council actions on the accessibility of homeopathic treatment. Proceedings are in progress.

National Conference on 1 October 2011 in Warsaw, Poland

The Polish Homeopathic Society will organize a national conference about the situation of homeopathy in Europe, which will be supported by the ECH and the LMHI and will be accompanied by press conference to catch the attention of the media. "We want to show the impact of homeopathy in medicine in some European countries and present research done in this field," says Kokoszczynski. "This event will be a good opportunity to explain homeopathy not only as an alternative medicine (CAM) but much more as an alternative way of treating desease (Salutogenesis).

The conference is titled Homeopathy in Europe – Practice, Idea, Research. The Water Logic of Homeopathy and aims at presenting the idea of homeopathy practiced in Europe and supported with significant homeopathic research.

Nobel Laureate Luc Montagnier

Support for Homeopathy in Science Interview

Dr. Luc Montagnier, the French virologist who won the Nobel Prize in 2008 for discovering the AIDS virus, surprised the scientific community with his strong support for homeopathic medicine in a remarkable interview published in the renowned Science magazine. Montagnier expressed support for the often maligned and misunderstood medical specialty of homeopathic medicine. Although homeopathy has persisted for more than 200 years throughout the world and has been the leading alternative treatment method used by physicians in Europe, most conventional physicians and scientists have expressed skepticism about its efficacy due to the extremely small doses of medicines used.

Montagnier made the following strong statement for homeopathy and homeopathic doses: "I can't say that homeopathy is right in everything. What I can say now is that the high dilutions are right. High dilutions of something are not nothing. They are water structures which mimic the original molecules. We find that with DNA, we cannot work at the extremely high dilutions used in homeopathy; we cannot go further than a 10¹⁸ dilution, or we lose the signal. But even at 10¹⁸, you can calculate that there is not a single molecule of DNA left. And yet we detect a signal."

Further, Montagnier referred to Dr. Jacques Benveniste, a French physician and scientist whose research into homeopathy has been widely criticised in mainstream science, as a "modern Galileo".

Although now 78, Montagnier will open a new research institute at Jiaotong University in Shanghai, China, where he will continue to explore electromagnetic waves produced by DNA in water. Asked for his motivation in the interview, he praised the Chinese for being "quite open-minded" with regard to this kind of medical and scientific research.

News about Homeopathy in Canada

Ever since the Natural Health Products Directorate was set up in Canada on 1 January 2004 and had thereafter regulated homeopathic medicines, the situation of homeopathy in Canada evolves at a greater pace. The Natural Health Products Regulations require all homeopathic medicines to have a license before being sold in Canada. License holders are issued a product number which must appear on the label of their product. The product number for homeopathic medicines is preceded by DIN-HM. As per the Canadian Law the homeopathic medicines are regulated by the Federal Government and the profession of Homeopathy is regulated by the provinces. Recently, in January 2011, a popular TV channel telecasted a special show questioning the efficacy of Homeopathy in the wake of Ontario homeopaths getting regulated, by quoting that since Ontario will be the first province to regulate homeopathy - Is Homeopathy a Cure or Con-lending credibility to this unproven practice. The entire homeopathic community of Canada joined together under one platform to condemn the TV show noting that the telecast showed complete lack of respect and understanding of a time honored system of medical treatment used around the world. All the homeopathic associations in Ontario and Canada have opposed such moves by the media through TV interviews by homeopathic experts and creating public awareness write ups in their respective web sites. There are more than 11 provincial and national level homeopathic associations in Canada – as may be seen from their active web sites

In wake of the Japan disaster many homeopathic groups have since started networking and exchanging their views about homeopathic remedies concerning homeopathic trauma remedies and also in dealing with cases related to the exposure of radiation through homeopathy. The Homeopathic Community all over Canada are therefore eagerly waiting for the regulations to come into force sooner or later and have joined their hands for holding International Homeopathic Conference under one bannerthe first of which is slated to be convened in the month of October 2011.

In Memoriam: An Obituary by Dr. Raj K. Manchanda

Dr. D. P. Rastogi (1939-2010) – An Ambassador of Indian Homeopathy



No possible words can describe the profound grief and sorrow the homoeopathic fraternity felt at the demise of Prof. Dr. Dhan Prakash Rastogi on 15 December 2010. He was the scientific Chairman of the LIGA Congress 2011 and was very regular in attending all the LIGA congress. He must have presented at least a dozen papers on diverse subjects. At Hahnemann's Birthday LIGA Congress in 2005, Prof. Ras-

togi was a special invitee. In 1977, he was the organizing secretary of the LIGA Congress held in New Delhi. He was a legendary homeopathic physician, a versatile teacher, clinician and researcher. He was an ambassador of India Homoeopathy.

Born on 8 May 1939 in Bijnor, District of Uttar Pradesh/ India, Dr. D. P. Rastogi was a bright and meritorious student and graduated from the Calcutta Homeopathic Medical College in 1958. He did DF (Hom) from Royal London Homeopathic Hospital and post-graduation from the Glasgow Homeopathic Hospital in 1962. Rastogi was among the first few homeopathic physicians appointed by the Government of India and was very popular among

patients. As Assistant Government Advisor on Homoeopathy he contributed significantly to the formulation of the Homeopathic Central Council Act of 1973, the introduction of the Homoeopathy in Drug and Cosmetic Act, the publication of the Homeopathic Pharmacopoeia of India, and the establishment of the Homeopathic Pharmacopoeia Laboratory and National Institute of Homoeopathy at Kolkotta. He served as Homoeopathic Physician to the President of India (1988-1992) and was conferred several awards in recognition of his services to Homoeopathy. As Principal of Nehru Homeopathic Medical College at New Delhi, he established a fully equipped 100 bedded hospital and upgraded the standards of education from diploma to degree during 1975 to 1984. Realizing his potential in research, Government of India appointed him Director of Central Council for Research in Homeopathy in 1985, where he gave new directions to Homoeopathic research in India

The Homoeopathic Medical Association of India dedicated its National Congress 2010 to his memory. His contribution to the association is remembered with great reverence.




Welcome to the 66th LIGA Congress in India

In reaction to long running anti-homeopathy campaigns in the United Kingdom, such as the "homeopathic overdose campaign 10:23" at the beginning of the year, British homeopaths have initiated an international project. Under the motto "Homeopathy works for me" they have called on patients to share their homeopathy success stories in self-produced videos about their health issues and the homeopathic treatment they used to obtain short-term relief and long-term healing. The project is an attempt to propagate the core message experienced by homeopathic physicians and patients: Homeopathy Heals. In addition to the effect of strengthening the public acceptance of homeopathy this international project might also be of scientific interest with regard to the large number of individual cases documented and recorded by patients.


Scientific Framework Homeopathy 2010

Clinical Efficacy of Homeopathy

Report of the LMHI Research Working Group

The LMHI Research Working Group Report has been asked for scientific advice by the Belgian LMHI member organization Unio Homeopathica Belgica (UHB) about the results of an official report on the clinical efficacy of homeopathy published by the Belgian Federal Health Care Knowledge Centre on 24 May 2011 ("Homeopathy : State of affairs in Belgium", www.kce.fgov.be). UHB expressed doubts about the scientific relevancy of certain parts of the KCE report, especially the part evaluating clinical efficacy concluding that "no convincing proof of efficacy exists for any condition for which a systematic review was available". The RWG agreed to scrutinize and comment on this report using the normal scientific perspective for evaluation of efficacy in medicine. About the clinical efficacy of homeopathy the RWG, among other findings, concludes that the "Efficacy of homeopathy for many diagnoses has never been investigated. More research is needed and must be supported." About the missing parts and wrong statements the RWG concludes that "Many missing parts lower the value of the recommendations of the KCE about homeopathic practice, safety and reimbursement of homeopathic practice and medicines. The KCE statement about efficacy of homeopathy is also questionable considering the absence of an evaluation of homeopathic veterinary practice, agro-homeopathy and fundamental research in homeopathy."
